MINUTES OF MEETING HELD ON MONDAY 21st APRIL 2015 AT 7.00pm

1. Public Participation: None

- 2. Declarations of any Personal or Prejudicial Interests by Members including consideration and decisions upon written requests for dispensation for disclosable pecuniary interests (if any): None
- 3. Minutes of the Meeting held on the 17th March 2015 had been circulated and were approved and signed.

4. Matters Arising:

- (a) Village Green: The Clerk contacted the Marquis of Hertford direct as a result of which a response has been received from the Ragley Estate Manager confirming that the Estate's Property Manager Steve Lyon has been asked to review the site so a more definitive response can be made.
- (b) Veterinary Laboratory Facility at Luddington: Ian Nixon of EMR Group had confirmed that the joint venture with Ainscough Strategic Land had withdrawn from their proposed acquisition of the site. The residents who asked to be kept informed had been notified.
- 5. County Councillor's Report: CCllr Horner sent a written report as follows:
 - (a) Warwickshire has produced a short video using a sound track donated by Ed Sheeran to publicize the dangers to young people of sex gang grooming. There are also a series of short audios going out on Coventry and Warwickshire radio. Warwickshire's child protection team is responding to the findings in the Jay Report on Rotherham.
 - (b) Warwickshire County Council's Adult and Community Learning team (ACL) have achieved re-accreditation to the national Matrix quality standard for information, advice and guidance. The ACL team has also been successful in securing £10,000 of funding from the Tinder Foundation to increase the number of people who have access to the Internet.
 - (c) The County is holding a Big Day Out weekend on May 16 & 17. The aim is to get everyone out and about and enjoying the outdoors and open spaces around them. It is hoped that by holding the event residents will recognise the health benefits, both physical and mental, that come from regular outdoor activity.
 - (d) The Annual Quality of Life in Warwickshire report is available on the Warwishire CC Observatory web site and has findings ranging from earnings and employment, to house prices and the county's booming population.
 - (e) The report says that by 2037 there will be almost 100,000 more people living in Warwickshire, and that one in six of the 624,000 people living in the county will be aged over 75 around 100,000 people. Currently about one in 12 of the population is aged over 75, just over 40,000 people. The Quality of Life report

says that while the ageing population can have health and social care implications, it can also have positives with increased volunteering, spending power and charitable donations.

- (b) The Annual Accounts for year ending 31st March 2015 were considered together with a comparison of the actual expenditure as against the budget. The Accounts were approved and the Annual Governance Statement was considered approved and signed.
- (c) SDC have confirmed that the Council will be receiving the sum of £1,183.38 in respect of residual funds arising from the dissolution of Old Stratford & Drayton PC

 - iii. £237.00 for P Rudge for work between 25th March 2015 and 13th April 2015
